D.O.B. Scholarship Program **ENROLLMENT GUIDE**

Who can and should apply to the D.O.B. scholarship program?

If your child is enrolled in a Catholic grammar school in Brooklyn or Queens (Pre K – 8th) and you are in financial need of tuition assistance you are eligible to apply. Your application will be taken under consideration of all families that have applied and ranked on a needy percentile.

How to apply to the D.O.B. scholarship program?

There are two ways to apply to the D.O.B. scholarship program:

1. Mail – You can receive a copy of the D.O.B. scholarship application at your school. You must include the school code for the school your child will attend, see the back of the application for the school code list. Please also remember that there is a \$21.00 application processing fee for all D.O.B. applications and to include a \$21.00 check or money order payable to PSAS. If there is no check or money order sent with your D.O.B. application, your application will not be processed and will be put On-Hold. Also note that it is one application per family not per student therefore there is only a one time processing fee.
2. Online – Go to www.psas.org and click the ‘Online Application’ to apply, authorization code=BROOK. Please note that there is a \$21.00 application processing fee for all D.O.B. applications. Also note that it is one application per family not per student therefore there is only a one time processing fee.

How can I check my D.O.B. application status?

Whether you mailed your application or filled out the online form you can check your D.O.B. application status. Simply go to www.psas.org and click on right button called the - ‘Application Status’ and enter your information.

If your status is:

- **Completed** – your application was received and is still being processed by PSAS.
- **In Process** – your application was received and is still under review. Use www.psas.org to monitor the progress of your application.
- **Expired** – your application was received incomplete and, after numerous attempts to obtain the required information, PSAS has expired the application. This means there will be no further action taken on this application and you will not be considered for a D.O.B. scholarship.
- **On Hold** – your application was received incomplete. Refer to the items listed and submit them to PSAS so that PSAS can continue with the processing of your application. No action taken can result in expiring your application.

When will I hear back about my D.O.B. application?

Please allow at least 6-8 weeks after round application deadlines for a response. See the front page of your D.O.B. application for round application deadlines.

When is the latest I can apply for a D.O.B. scholarship?

In order to be considered for a D.O.B. scholarship, your application must be postmarked no later than last round deadline. We strongly recommend applying as early as possible to qualify for an award.
